ORDER OF RESTRAINT

TO: Dakhma of Angra Mainyu Syndicate

This matter is before the Court on the verified petition of Plaintiff, the Most Reverend Paul S. Coakley, as Roman Catholic Archbishop of Oklahoma City (“Archbishop Coakley”), seeking an order restraining Defendant, Dakhma of Angra Mainyu Sydicate (“Dakhma”), Dakhma’s agents, employees, and all others who are under Dakhma’s control from concealing, damaging, destroying, or removing from Oklahoma County, the following personal property, pending a hearing on Archbishop Coakley’s request for an order for the prejudgment delivery of the property:

Any and all hosts or communion wafers in your possession that have been consecrated, blessed, or used during a Catholic Mass.

Based on the verified petition of Plaintiff and pursuant to 12 Okla. Stat. § 1571(C), this Court finds that:

1. Archbishop Coakley has alleged sufficient facts in the verified petition to support a claim for replevin of the personal property described above; and

2. There is a danger that Dakhma, Dakhma's agents, employees, or others who are under Dakhma's control may conceal, damage, destroy, or remove the personal property described above from Oklahoma County, unless this Court issues an order of restraint immediately and without notice to Defendant.

IT IS THEREFORE ORDERED that pending a hearing on Archbishop Coakley's request for an order for the prejudgment delivery of the property, Dakhma, Dakhma's agents, employees, and all others who are under Dakhma's control are temporarily enjoined from concealing, damaging, destroying, or removing from Oklahoma County, the personal property described above.
